Besides the great work of Lord Redesdale, he is especially indebted for assistance to Daniell's Chancery Practice, with the notes of successive editors, including those of Chancellor Cooper; Bump's annotations of the statutes regulating Federal Procedure; and the manuscript lectures on equity pleading delivered before the Law School of Boston University, by the late Judge Dwight Foster.
