Contributors argue that the process of hybridization, and hybrid rule point towards a convergence on a more authoritarian capitalist regime type, possibly, but not necessarily, more closely aligned with the Beijing model—one toward which even the United States, with its penchant for surveillance and discipline, appears to be moving.

This volume will shed new light on evolving public-private relations, and the changing nature of power and political authority in the 21<sup>st</sup> century and will be of interest to students and scholars of IPE, international relations and political theory.
